**YRH FOSTER-to-ADOPT CONTRACT**

NAME OF DOG BEING PLACED: \_\_\_\_\_

I/We, \_\_\_\_\_ (hereinafter referred to as “FOSTER FAMILY”), enter willingly into this Foster-to-Adopt Contract and acknowledge receipt from YORKIE RESCUE HOUSTON (hereinafter referred to as “YRH”) one or more foster dogs into my home. I/We understand that YRH may request that I foster another dog or dogs in the future. I/We hereby agree that the execution of a separate Foster-to-Adopt Contract will not be necessary for future foster arrangements that I/we may volunteer to provide for YRH. I/We agree to comply with the terms and conditions of this Foster-to-Adopt Contract in any such future arrangements. I/We understand that this Foster-to-Adopt Contract can be amended as needed for the best consideration of the dog(s) and YRH. In addition, FOSTER FAMILY agrees to the following terms and provisions:

**TERMS AND CONDITIONS**

1. FOSTER FAMILY agrees to take the dog(s) to an approved YRH licensed veterinarian, at YRH’s expense, for the following vaccinations and tests at the intervals required by law and/or advised by an YRH intake team member or approved YRH licensed veterinarian:
  - a. physical examination;
  - b. Rabies, Distemper/Parvo combination,
  - c. Fecal (intestinal parasite) test
  - d. heartworm test, followed by a regular course of preventative. (Provided by YRH)

**ANY ADDITIONAL VETTING IS WITHOUT PRIOR APPROVAL IS THE FOSTERS FINANCIAL RESPONSIBILITY**

It is YRH’s policy to keep all foster dog(s) under veterinary care until they are adopted. If the dog requires medication during the foster period, FOSTER FAMILY agrees to administer such medicine pursuant to instructions provided by an approved YRH licensed veterinarian or a YRH director.

2. FOSTER FAMILY agrees to provide this dog(s) with a safe home, proper care and attention, and humane treatment in accordance with all current and future state, county, and local laws and ordinances where FOSTER FAMILY resides. The dog(s) is not to ride loose in the back of trucks, left unattended in a vehicle, is not to be chained or tied-out, allowed to run or roam loose and the FOSTER FAMILY warrants that the dog(s) will not be contained solely by a hidden fence or electric fence. The dog(s) is not to be solely an outside pet nor housed outside or in a kennel run. FOSTER FAMILY agrees that the dog(s) will be indoors when the FOSTER FAMILY is away from the home. FOSTER FAMILY agrees to provide prior notice to YRH before a change of home address during any foster period.

3. FOSTER FAMILY agrees to take the dog(s) to an approved YRH licensed veterinarian to provide the dog(s) with necessary veterinary care when indicated by symptoms of sickness, disease, and injury. Upon

emergency, FOSTER FAMILY agrees to get prior approval from a YRH director before taking the dog(s) to an Emergency Veterinarian Clinic or Hospital. A list of approved vets and emergency clinics will be given to the foster family. A contact list of YRH's directors will be given to the FOSTER FAMILY.

4. FOSTER FAMILY understands that there are costs involved in maintaining a dog(s), and agrees to assume full responsibility for wholesome food & sanitary water, grooming, and basic health issues including administering the monthly heartworm preventative (provided by YRH) and **flea prevention if necessary (provided by rescue)**. Please note that YRH will not pay for any cosmetic procedures without prior approval from the YRH Board of Directors. It is against YRH's policy for any FOSTER FAMILY to add any unnecessary items to YRH's veterinary bill UNLESS such items are absolutely necessary and prescribed by an approved YRH licensed veterinarian and approved by the YRH Board of Directors. Examples of such items include: dental cleanings, mole removal, lump removal, tooth extraction. Further, it is forbidden for any FOSTER FAMILY to add any unnecessary items to YRH's veterinary bill such as treats, toys, food, vitamins, grooming, shampoo, boarding, etc. without prior consent from the Board of Directors. If YRH receives a bill for such items described above, the FOSTER FAMILY agrees to reimburse YRH for such items immediately.

**5. Under no circumstances will FOSTER FAMILY feed FOSTER DOG:**

- 1) Alpo
- 2) Beneful
- 3) Blue Buffalo (all varieties)
- 4) Dog Chow
- 5) Gravy Train
- 6) Iams
- 7) Kibbles-n-Bits
- 8) Old Roy
- 9) Pedigree
- 10) Any Grain Free food (unless there is a medical need)
- 11) A vegetarian diet

6. FOSTER FAMILY also agrees that they will talk to their personal vet about their fostering, and to seek advice whether he/she recommends a six-month Parvo booster and Bordetella on the family's personal pets to prevent any breakout. If FOSTER FAMILY decides NOT to take the extra precaution with the additional recommended boosters, YRH will not be responsible for any expenses for the family pets if there is a Parvo or Bordetella outbreak in the home.
7. FOSTER FAMILY agrees that the dog(s) will reside in his/her home, will be kept as a household pet, and will not be used for breeding, fighting or as a hunting or guard dog(s). FOSTER FAMILY further agrees that the dog will not be entered into any type of service dog training program without the written approval of YRH Director.
8. FOSTER FAMILY agrees to provide a breakaway cat collar and an identification tag for the dog(s) to wear at all time. Foster agrees this is never to be used to walk the dog. YRH recommends a harness for all dogs. Training collars are ONLY acceptable when working with a professional trainer. FOSTER FAMILY agrees to notify YRH immediately if foster dog(s) should become lost or separated from FOSTER FAMILY.
9. FOSTER FAMILY agrees to notify a YRH director immediately in the event of any incident of biting or any aggressive behavior demonstrated by the foster dog(s). YRH makes no warranties or representations regarding the dog(s)'s health or temperament. It is agreed and understood by FOSTER FAMILY that while every effort is made to provide an accurate history and assessment of a dog(s), YRH does not warrant any dog(s) regarding medical status, behavior, or disposition. It is further agreed that environmental changes may effect and change the temperament of the above named dog(s) and that YRH has no liability or responsibility of any nature regarding defects with the dog(s), or injuries or damage to any person or property which may be caused by the dog(s). FOSTER FAMILY agrees to indemnify and hold harmless YRH, its members, officers, directors, agents, and their heirs, administrators, executors, successors and representatives against any and all claims, known or unknown, now or hereafter arising in connection with this dog(s).
10. FOSTER FAMILY consents to the examination of this dog(s) by YRH at any time for any reason and acknowledges that YRH has the right to reclaim the dog(s) at any time for any reason including failure to comply with the terms of this contract or for any misrepresentations of fact FOSTER FAMILY made on the Foster application or in this contract. In the event the dog should be returned to or reclaimed by YRH, FOSTER FAMILY agrees to be financially responsible for any medical issues due to neglect by FOSTER FAMILY. Further, if the dog(s) sustains injuries or illness due to the improper care or neglect from FOSTER FAMILY, then FOSTER FAMILY will be responsible for all medical costs resulting from such neglect or improper care.
11. **FOSTER FAMILY agrees that if for any reason he/she cannot keep this dog(s), he/she shall give YRH 2 weeks' notice to find a suitable foster. If 2 weeks' notice is not possible, FOSTER FAMILY agrees to pay 2 weeks boarding at facility of YRH choosing. The dog(s) shall not be given away, sold, exchanged or adopted without the prior written consent of YRH. FOSTER FAMILY understands that any friend or family member who wishes to take ownership of this dog(s) will be required to apply to YRH for the right to adopt and/or foster it.**
12. YRH retains the right to refuse anyone from adopting any YRH dog for any reason.
13. **It is understood that the intent of FOSTER FAMILY is to ADOPT this dog at the end of the FTA period. Foster family makes this commitment to the dog by paying 1/2 the adoption fee at the time of this signing. The balance will be due at the time of final vetting. Should Foster family, for ANY**

**reason, decide NOT to adopt this dog, Foster family forfeits any payments made.**

- 14. YRH retains the right to refuse anyone from adopting any YRH dog for any reason.
- 15. The purpose of this Foster-To-Adopt is to allow the dog(s) to complete its medical treatments (i.e. heartworm treatment, hookworm treatment, spay, neuter, etc.) FOSTER FAMILY agrees to work with YRH to attend all appointments and follow-up visits that need to be made in order to have the dog(s) healthy and ready for adoption. FOSTER FAMILY acknowledges that until this has been accomplished, YRH has the right to and will reclaim the dog(s) if the appointments are not made and met.
- 16. It is agreed and understood by FOSTER FAMILY and YRH that this written agreement sets forth all promises, agreements, conditions, and understanding between them, oral or written, and that both parties have fully read and understood all of this agreement.
- 17. FOSTER FAMILY agrees to pay YRH for any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms and provisions of this contract. Payment of these damages shall not excuse FOSTER FAMILY from returning the dog(s) to YRH.

FOSTER FAMILY hereby releases, indemnifies and holds harmless YRH, its officers, directors, members, agents and their heirs, administrators, executors, successors and representatives from any and all liability and claims of any and every nature and cause, known or unknown, now or hereafter directly or indirectly relating to any YRH dog(s). By signing below, FOSTER FAMILY hereby affirms and declares: I/we have read and understand all of the terms of this Foster-to-Adopt Contract. By signing this Foster-to-Adopt Contract, I/we agree to abide by all of its terms and conditions. I/We am/are signing this Foster-to-Adopt Contract on my own free will, and I/we am not under any duress of any kind. I/We have never been investigated, charged, or ticketed with cruelty to any animal. IN TESTIMONY WHERE the FOSTER FAMILY and YRH have set their signatures on this the date first above written.
